Your correspondence of April 6, 2020, addressed to Ms. Mitzi Dean, MLA and Parliamentary

Secretary for Gender Equity, containing proposed amendments to the Enhanced Care legislation, and to the *Family Compensation Act*, has been referred to me as the Minister responsible for the Insurance Corporation of British Columbia (ICBC).

I had requested your organization meet with ICBC Senior Manager of Road Safety Policy and Programs, Jerome Atherton, and with members of ministry and ICBC staff, and I understand these meetings took place on April 23 and June 8, 2020, respectively.

Government has received, and is reviewing, your submissions as part of ongoing consultation with a large number of stakeholders regarding the transformational changes we are making to reform our auto insurance system in BC – changes that place a priority on affordability and on care and recovery for any British Columbian injured in a motor vehicle crash.
