Dear MLA Eby,

This is Michael-James Pennie, President (volunteer & donor) of The BC Wrongful Death Law Reform Society (intheirname.ca) writing to you.

I wanted to let you know about the success of our Mothers for Justice Memorial Walk to Premier David Eby's office on May 13, 2023, which your constituents either attended or provided support towards.

The purpose of the walk was to raise awareness of the fact that BC is the last province in Canada—and one of the last in the G7—to modernize its wrongful death laws. Human life is presently worthless in our province under the condescendingly named *Family Compensation Act* for those who do not meet the discriminatory criteria of being a breadwinner with young dependent children.

We received excellent coverage from Global, CTV, CBC, CityTV, Hamyaari Media, and the Cloverdale Reporter.

It was, however, noted that Premier Eby refused to acknowledge the families or provide a statement to media. By Monday morning, all of the photos of our wrongfully killed loved ones were ripped down from his constituency office window.

Media was deferred to the AG office, which released a statement, that was also reiterated in the Vancouver Sun article I was interviewed for this past weekend:

"In a statement, the Ministry of the Attorney General said, 'Grieving families need better support when there is a wrongful death.' The ministry is 'working to update the family compensation act to give families an opportunity to address the injustice they have faced.""

I wanted to let you know that the AG office's statement is completely out of touch with what

every family has been asking for in the past 25+ years.

The word "support" has never been uttered by a single family. The only words and phrases I have ever heard from a family's mouth after their loved one was killed and they were denied access to justice under the *FCA* are as follows:

'Truth', 'justice', 'accountability', 'having our day in court', 'public record', 'righting a wrong', 'dignity', 'financial penalty against wrongdoers', 'making sure it doesn't happen to others', 'deterrence', 'safety incentives', 'compensation for our immeasurable loss of care, guidance, love, affection, companionship, and having our lives destroyed'.

The families affected through this lived experience want the *FCA* repealed and replaced with our drafted *Wrongful Death Accountability Act (WDAA)*, which includes these 5 key tenets (see *Appendix A*).

I've worked with volunteer law students for the past several years researching wrongful death legislation from across Canada. We cherry-picked the best aspects from each of the provinces. We've had some of the brightest legal minds in the human rights community look this over and they all feel strongly that this is long overdue.

It is time to shed the colonial-era relics of our province's past and actually bring forth a modern standard of human dignity and legislated protections under the law that will value all individuals in our province.

Many of you claim to be defenders of human rights, although unfortunately, you cannot claim to do so, unless human life has value under the law and there is legal remedy to enforce that right when wrongfully killed.

All surviving families deserve access to the independent judiciary, to be able to retain legal representation on a contingency basis—a model which doesn't discriminate socioeconomically—and to have their day in court.

I am calling on you MLA Eby, to write a letter of endorsement to Premier David Eby and Attorney General Niki Sharma in support of repealing the *FCA* and replacing it with our drafted *WDAA*, inclusive of the 5 key tenets the families have demanded.

Vancouver City Councillor Pete Fry got this endorsement passed at the UBCM in 2021. MLA Routley endorsed this in 2021. As did MLA Mercier and MLA de Jong.

All of these aforementioned MLAs have 'A' grades in our MLA report card system as a result, which will allow us to educate the public in advance of the next election.

MLA Eby, can the families and I count on you to support your constituents and endorse human life having value and legislated protections under the law?

I look forward to your action concerning this matter and I would appreciate if you cc me with any endorsement correspondence with Premier Eby and Minister Sharma at admin@intheirname.ca.
