I have a request for Monday at 12 noon for a story I am working on about a family who allege their mother died as a result of neglect in a Prince George long-term care facility: <https://ckpgtoday.ca/2023/01/12/family-alleging-negligence-of-care-home-in-mothers-death/> They are frustrated by current laws that limit compensation, other than funeral and burial costs, to lost income, as their mother did not work.
